CommunityCare™ *Health and Wellness*

CommunityCare has extensive wellness experience and resources. Health screenings, assessments, lectures and health promotion programs will be offered to ChamberCare Plus members at prices significantly below that of independent third party vendors. Onsite programs at the chamber for their enrolled small businesses will take place, and online wellness tools at a dedicated microsite will be made available as well. ChamberCare Plus businesses will have wellness tools and resources generally available only to large employers. Full biometric screenings for only \$25 per participant will be subsidized 50/50 with the employer. A central location model with advanced registration will be employed. Numerous other wellness services, including flu shots, will be available.

Employee Assistance Program

CommunityCare is Oklahoma's leading EAP provider with over 300 employer groups and 142,000 members. CommunityCare EAP provides not only services to employees to help identify and resolve problems, but it also provides training and consultation to management. The EAP also provides three qualified substance abuse professionals (SAPs) to assist organizations that fall under the Department of Transportation.



The economies of scale involved in a chamber program allow us to structure a unique EAP program for their small businesses. Pricing for the program has been discounted by 20%. For small businesses with 25 or fewer employees, the EAP cost will only be a \$12.50 flat fee total per month. Groups with 26-50 employees will only pay \$0.70 per employee per month.

EAP is a proven, cost-effective solution to many of the problems employers face today. Research shows that each dollar invested in an EAP saves the employer \$5-\$16.

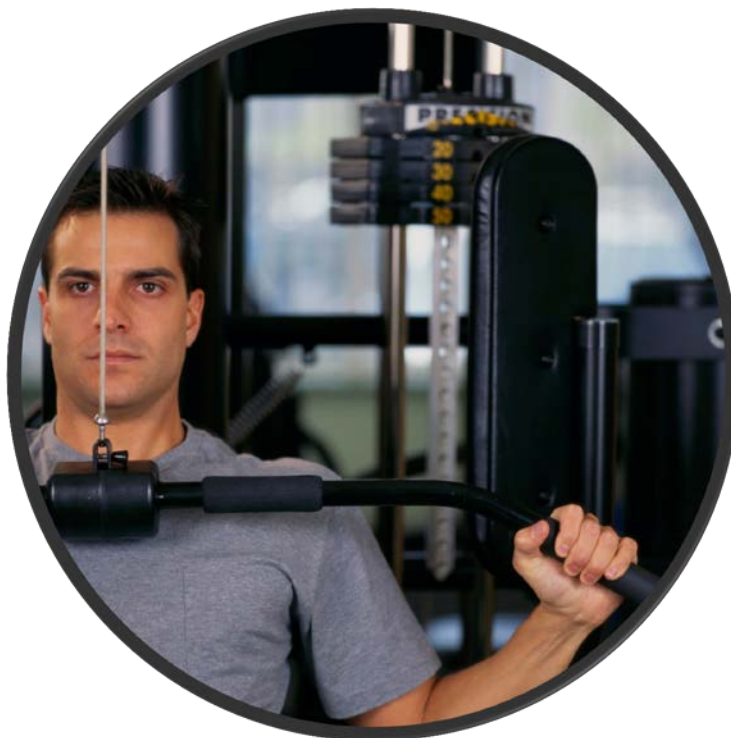
At any given time, 20 percent of the workforce has personal problems that impact their job. According to the National Institute of Mental Health, 30 percent of all absenteeism and 66 percent of all terminations are related to employees' personal problems. Troubled employees are 25 percent less productive than the average worker.

EAPs can reduce sick leave usage by 33 percent, work-related accidents by 65 percent, workers' compensation claims by 30 percent, grievances by 50 percent and time spent on supervisor reprimands by 74 percent.
